

## 2022–2023 Verification of 2020 Income Information - INDEPENDENT

Your 2022–2023 Free Application for Federal Student Aid (FAFSA) has been selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information, the Financial Aid Office (FAO) will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the FAO. Western Piedmont Community College (WPCC) may ask for additional information. If you have questions about verification, contact your FAO as soon as possible so that your financial aid will not be delayed. **PLEASE COMPLETE IN INK.**
